Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Habeas Corpus to call for the entire records relating to the petitioner's son's detention under Tamil Nadu Act 14 of 1982 vide detention order, dated 04.12.2018 on the file of the second respondent herein, in proceedings Memo C.No.129/G/IS/2018, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's son namely K.Jaisingh, S/o.Koilpitchai, aged 29 years, before this Court and set the petitioner's son at liberty from detention, now the petitioner's son detained at Central Prison, Coimbatore.

2. In the light of the said development, nothing remains for further adjudication in this Habeas Corpus Petition and accordingly this petition is dismissed as infructuous.

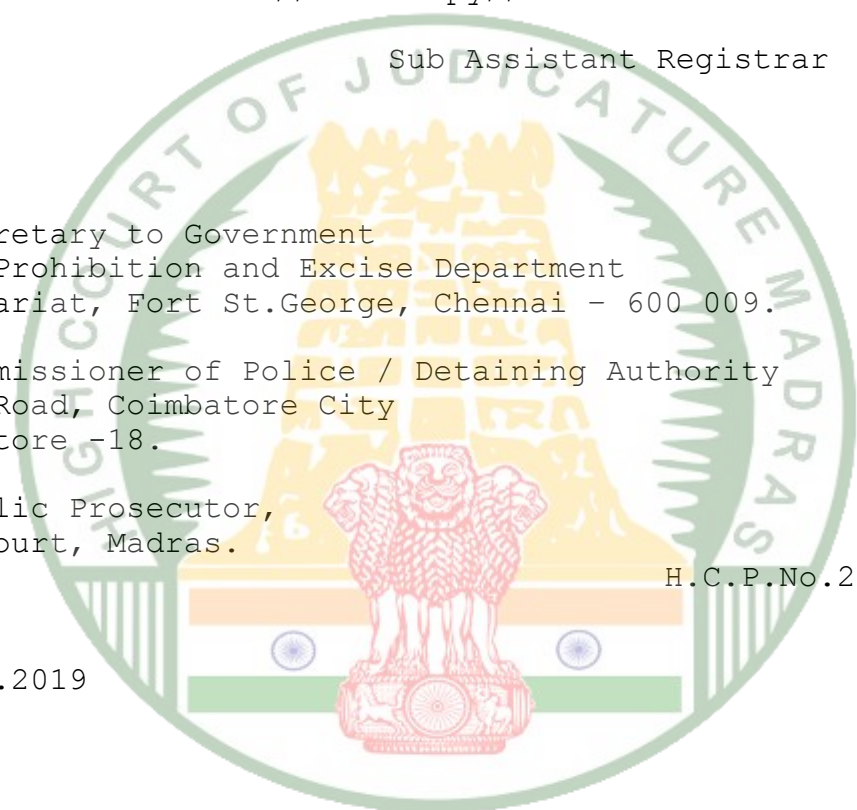
