Having regard to the facts and circumstances of the case, this miscellaneous petition is allowed and the substantive sentence of imprisonment alone is suspended and the petitioner is released on bail on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for

a like sum to the satisfaction of the learned XVI Metropolitan Magistrate Court, George Town. Further, the petitioner shall appear before the respondent police on the first working day of every month at 10.30 a.m until further orders.
