2.Earlier, while suspending the sentence, this Court has imposed condition to the effect that the petitioner shall appear before the respondent on the first working day of every month at 10.30 a.m., vide its order dated 11.08.2017, in Crl.M.P.No.8797 of 2017 in Crl.A.No.318 of 2017. When the matter is taken up for hearing today, it is represented by the learned counsel for the petitioner/accused that the said condition has been duly complied with by the petitioner/accused. The said fact has also been acknowledged by the learned Government Advocate (Crl.side).

3.In view of the above said fact, the condition imposed for appearance of the petitioner/accused before the respondent on the first working day of every month 10.30 a.m., shall stand deleted and this petition is allowed.
