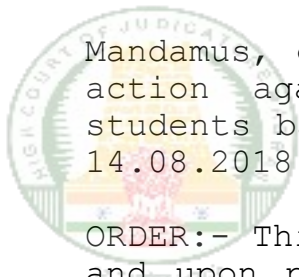
Common Prayer in Cont. P(md) No.1724 to 1729 of 2019:-
