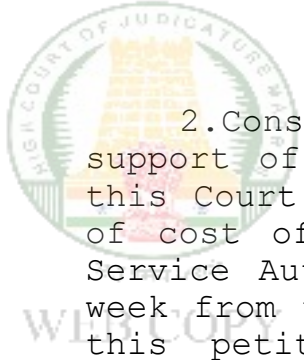

PRAYER IN CMA(MD) No.SR757 of 2019:

To set aside the award dated 09.07.2018 made in W.C.No.256 of 2014 on the file of the Commissioner of Workmen Compensation (Deputy Commissioner of Labour), Tiruchirappalli and allow the appeal with costs and thus render justice.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.J.S.MURALI, Advocate for the petitioner and of MR.D.BOOPAL.
