PRAYER IN CMA(MD) No.SR600 of 2019

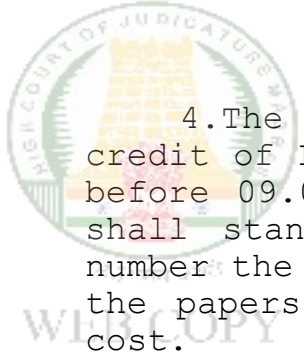
