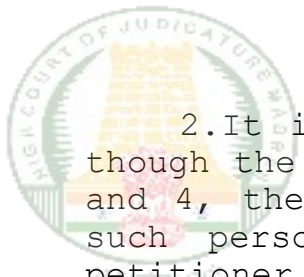

Prayer in CRP(MD). 2632/ 2010 :

To set aside the order dated.3.3.2010 in I.A.No.38/2010 in O.S.No.62/2008 on the file of the Subordinate Judge, Devakkottai and allow the I.A.No.38/2010 in O.S.No.62/2008 by allowing this Revision Petition and thus render Justice.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.R.SUNDAR SRINIVASAN, Advocate for the petitioner, the court made the following order:-

This petition has been filed by the petitioner with a prayer for effecting service on the proposed respondents 3 and 4 by substituted service, i.e., by publication in a Tamil Daily, as difficulty was encountered in serving the said respondents through the usual modes.



2.It is stated by the learned counsel for the petitioner that though the petitioner has sent notice to the proposed respondents 3 and 4, the same have been returned as 'no such addressee' and 'no such person'. Hence, he requested this Court to permit the petitioner to effect substituted service.

3.Considering the above submission, the petitioner is permitted to serve notice to the proposed respondents 3 and 4 through substituted service by effecting paper publication in 'Malaimalar' Tamil Daily in Erode Edition by duly indicating the date of next hearing as 15.04.2019.

5.The petition is ordered accordingly.
