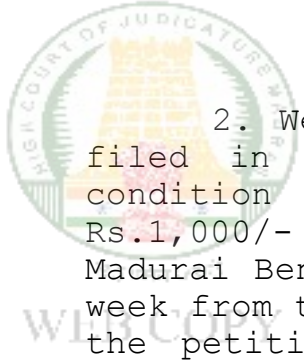
PRAYER IN CMA(MD) No.SR21502 of 2016:
