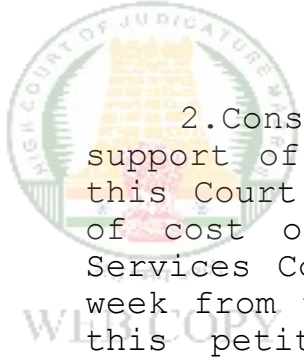
PRAYER IN SA(MD) No.SR34531 of 2014
