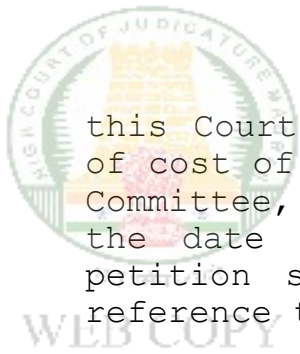
PRAYER IN CRP(MD)(PD).No.2520 of 2017:-
