Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to condone the delay of 840 days in representation in the appeal in CMA(MD)SR.No.34652 of 2016 filed against the order and decree dated 26.10.2015 passed in MCOP No.362 of 2015 on the file of the Motor Accidents Claims Tribunal Judge/Special Subordinate Judge at Tanjore and thus render justice.

PRAYER IN CMA(MD) No.SR34652 of 2016:

To set aside the judgment and decree passed by the Motor Accident Claims Tribunal (Special Subordinate Judge) of Tanjore in MCOP No.362/2009 dated 26.10.2015 and allow the appeal with costs and thus render justice.

This Civil Miscellaneous Petition has been filed to condone the delay of 840 days in re-presenting the above said appeal.

3.Being satisfied with the reasons stated in the affidavit filed in support of this petition, this petition is allowed with cost of Rs.5,000/-.

The petitioner is directed to pay a sum of Rs.5,000/- to the credit of Chief Justice Relief Fund, Madurai Bench of Madras High Court, Madurai, on or before 25.04.2019, failing which, the delay condoned by this Court shall stand vacated automatically. The Registry is directed to number the appeal and post the same on 25.04.2019 under the caption "for admission" if the papers are otherwise in order and after showing the proof of cost.
