PRAYER IN SA (MD) No.SR48399 of 2018:

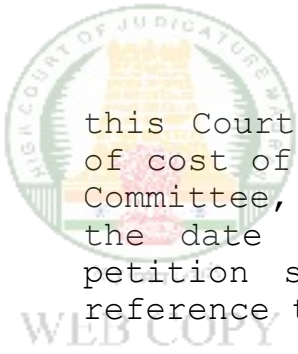
