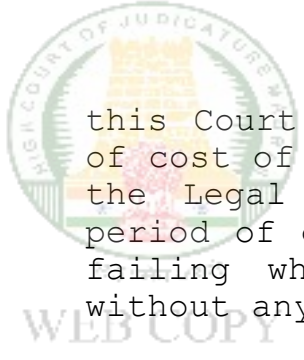
PRAYER IN SA(MD) No.SR13921 of 2017:
