PRAYER IN CMA(MD) No.SR15136 of 2018:

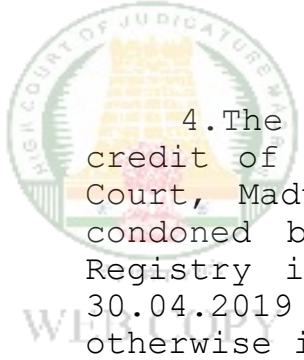
