4.The petitioner is directed to pay a sum of Rs.500/- to the credit of Chief Justice Relief Fund, Madurai Bench of Madras High Court, Madurai, on or before 23.04.2019, failing which, the delay condoned by this Court shall stand vacated automatically. The Registry is directed to number the appeal and post the same on 24.04.2019 under the caption "for admission" if the papers are otherwise in order and after showing the proof of cost.
