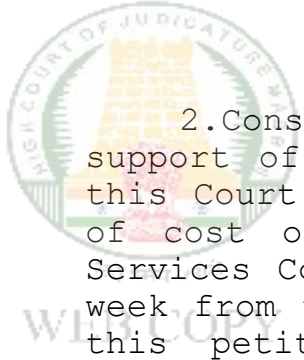
PRAYER IN SA(MD) No.SR9716 of 2016:
