Being satisfied with the reasons stated in the accompanying affidavit filed in support of this petition, the delay of 396 days in filing the appeal is condoned with cost of Rs.500/- to the credit of Chief Justice Relief fund, within a period of two weeks from the date receipt of a copy of this order and also deposit 50% of the award amount to the credit of M.C.O.P.No.255 of 2014, on the file of the Motor Accident Claims Tribunal, Sub Court, Kulithalai, within a period two weeks from the date of receipt of a copy of this order, failing which, this Civil Miscellaneous Appeal will be automatically rejected.



2. Registry is directed to number the appeal, if it is otherwise in order.

3. Post the appeal after two weeks.
