PRAYER IN CMA(MD) No.SR45015 of 2018:

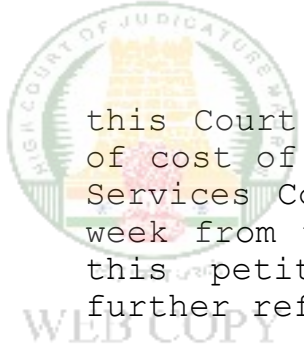
