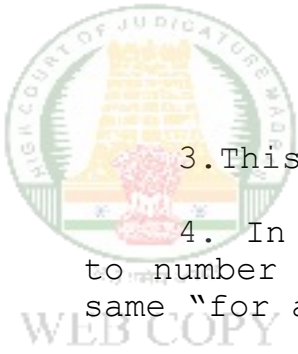
**PRAYER IN CRP (MD) No.SR7655 of 2017:**
