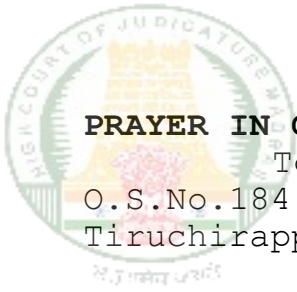
PRAYER IN CRP(MD) .NO.525 of 2019

PRAYER IN CMP(MD) SR.No.3494 OF 2019:

To passed an order of interim injunction restraining the respondents 1 and 2 and their men and agent from encroaching upon the schedule property or from interfering with my peaceful possession and enjoyment of the schedule property.

Schedule of Property: All that piece and parcel of the land comprised in Old.S.No.6/1,6/2,6/3,6/4,7/3 and 7/4, present T.S.No.9/1, Block No.4, K.Sathanoor Village, Trichy Taluk, within the corporation Limits of Trichirapalli to an total Extent of 4 acres and 48 cents or there about along with Asphestra Sheet Roofed 500 Sq.Feet Shed and compound wall is the schedule property.

**PRAYER IN CMP(MD) SR.No.3495 OF 2019:**

To stay the operation of the judgment and decree in O.S.No.184 of 2015 on the file of the Principal District Judge, Tiruchirappalli dated 09.04.2016.
