PRAYER IN CRP SR.No.11948 of 2017:

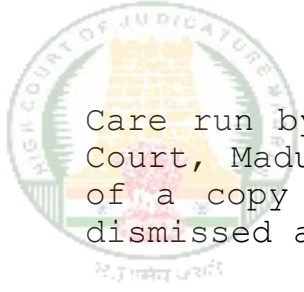
