Prayer in CRL MP(MD) . 10240 OF 2018 :

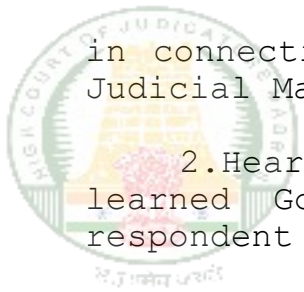

Prayer in CRL RC(MD) . 205/ 2018 :

Revision filed under Section 397 read with section 401 of the Code of Criminal Procedure, to call for the records in C.A.no. 30 of 2016 dt.23.02.2018 on the file of the First Additional Sessions Judge, Thoothukudi in confirming the judgment of conviction under Section 409 IPC and modifying the sentence of 3 years to one and half years and modifying the fine amount of Rs.7,5../- fro, 10,000/- in C.C.No.57 of 1999 dt 15.07.2016 on the file the Judicial Magistrate court NO.1, Thoothukudi and allow the revision and acquit the revision petitioner.
