Prayer in W.P(MD)No.12511 of 2011: Writ Petition is filed under Article 226 of the Constitution of India for issuance of Writ of Certiorarified Mandamus calling for the records of the respondents particularly that of the first respondent's impugned order of cancelling the quarrying the lease in Na.Ka.No.1906/2011 (mines) dated 02.10.2011 and quash the time as without jurisdiction, illegal, unlawful and against the principles of natural justice and consequently direct the first respondent to permit the petitioner to continue the quarrying operations until 30.12.2017.
