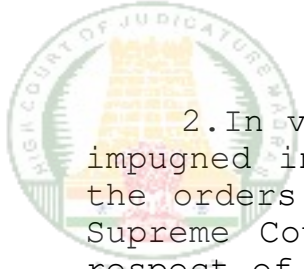

The parties to the lis on hand have already filed Writ Appeal against another order and the review filed against the writ appeal order was also rejected. Subsequently, the orders passed by the Division Bench both in Writ Appeal as well as in Review Application were confirmed by the Supreme Court. Finally an order dated 16.09.2014 passed in W.A.[MD]No.553 of 2012 was implemented.
