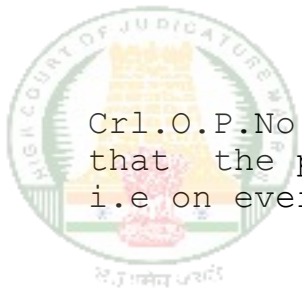
This petition has been filed to relax the condition imposed on the petitioner in Crl.O.P.No.20351 of 2018 on 23.11.2018.
