Prayer in CRL MP(MD). 1878/ 2019 ::-

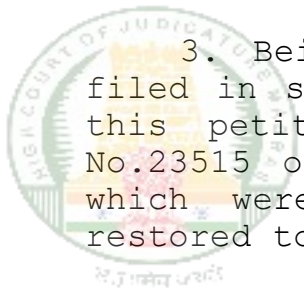
