This Writ Petition is filed by the petitioner challenging the order refusing to regularise the period of 250+60 days in two different spells and treat those period as leave period without pay.

2.During the pendency of the Writ Petition, the respondent Management appears to have passed a resolution to regularise the

entire period of 310 days as duty period, so as to enable the petitioner to get salary for the said period from the Government.
