Prayer in CRL MP(MD).1934/2019 IN CRL OP(MD)No.2203/2018:

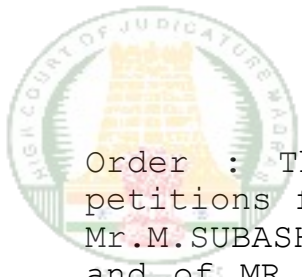
