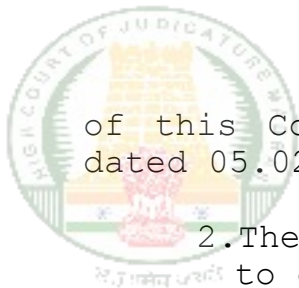
Prayer in CRL MP(MD).1940/2019 in CRL OP(MD)No.22960/2019:
