2.The learned counsel for the petitioners seeks time to produce sureties. Since there was a difficulty in arranging the sureties, the petitioners are unable to execute the sureties within the stipulated time as per the order of Crl.O.P(MD) No.21707 of 2018 dated 06.02.2019.

3.In view of the same, time granted by this Court in Crl.O.P (MD) No.21707 of 2018 dated 06.02.2019 is extended further for a period of two weeks from the date of receipt of copy of this order,



failing which the anticipatory bail already granted by this Court shall stand vacated automatically.
