PRAYER IN CRL MP(MD).2478/19:

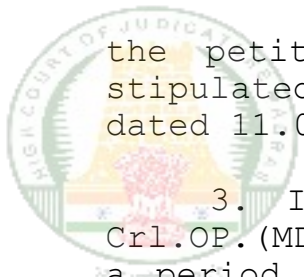
