3.The learned Government Advocate (Cr1.side) has no strong objection to modify the condition No.(iii).

4.Taking into consideration of the submissions made by both the counsel, the condition No.(iii) imposed by this Court in Cr1.A(MD) No.320 of 2018 on 03.08.2018 is modified to the effect that the petitioner shall report before the Tharavi Police Station, Mumbai once in a week i.e., on the first working day of every week at 10.30 a.m until further orders. The other conditions shall remain unaltered.
