2.At the time of hearing the criminal original petition, the prosecution has clearly stated that a charge sheet has been filed before the Court concerned and upon hearing the said submission made by the prosecution, this Court dismissed the bail petition with a direction to the Court to complete the trial within a period of six months from the date of a receipt of a copy of this order.

Thereafter the learned counsel for the petitioner filed copy application to the concerned court for getting charge sheet copies and the same was returned with endorsement by stating that no charge sheet has been filed in the above criminal case. Therefore the petitioner has approached this Court for relief as stated supra.



3. Considering the facts and circumstances of the case and also considering the submissions made by the learned counsel for the petitioner, this petitioner is ordered and the order in CrI.O.P.(MD)No.2864 of 2019 is recalled and restored to file.
