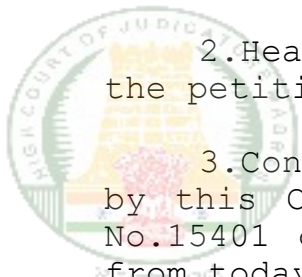
Prayer in CRL OP(MD).No.15401 of 2018 :-
