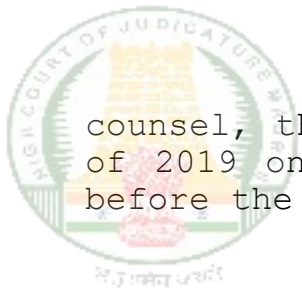
This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD)No.2945 of 2019 on 26.02.2019.
