3.In view of the same, time granted by this Court in Crl.O.P (MD) NO.716 of 2019 dated 05.03.2019 is extended further for a period of two weeks from the date of receipt of copy of this order,



failing which the anticipatory bail already granted by this Court shall stand vacated automatically.
