2.While granting anticipatory bail, the learned counsel for the petitioner, on instructions, would submit that the petitioners are ready to deposit Rs.10,00,000/- to the credit in crime number. Now he seeks for modification.



3. Contrary to his stand, has filed a modification petition, hence filing the modification petition does not arise.

4. Hence the modification petition is dismissed, however time is extended further for a period of four weeks from the date of receipt of copy of this order, failing which the anticipatory bail already granted by this Court shall stand vacated automatically.
