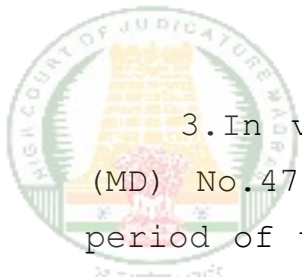

2.The learned counsel for the petitioner seeks time to produce sureties. Since there was a difficulty in arranging the sureties, the petitioner is unable to execute the sureties within the stipulated time as per the order of Crl.O.P(MD) No.4775 of 2019, dated 29.03.2019.
