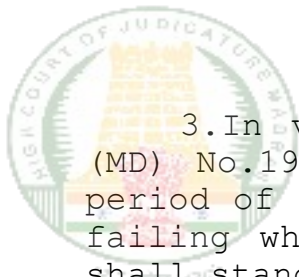

This petition has been filed to extend the time limit of the petitioner to execute the sureties and surrender before the concerned Magistrate Court.

2.The learned counsel for the petitioner seeks time to produce sureties. Since there was a difficulty in arranging the sureties, the petitioner is unable to execute the sureties within the stipulated time as per the order of Crl.O.P(MD) No.1942 of 2019, dated 26.02.2019.
