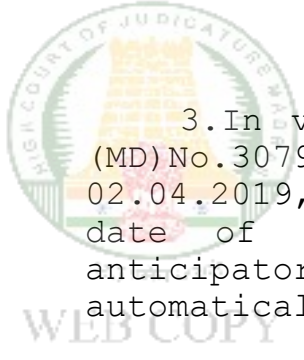

2.The learned counsel for the petitioners seeks time to produce sureties. Since there was a difficulty in arranging the sureties, the petitioners are unable to execute the sureties within the stipulated time as per the order of Crl.M.P(MD)No.3079 of 2019 in Crl.O.P(MD) No.2260 of 2019, dated 02.04.2019.

In view of the same, time granted by this Court in Crl.M.P (MD) No.3079 of 2019 in Crl.O.P(MD) No.2260 of 2019, dated 02.04.2019, is extended further for a period of two weeks from the date of receipt of copy of this order, failing which the anticipatory bail already granted by this Court shall stand vacated automatically.
