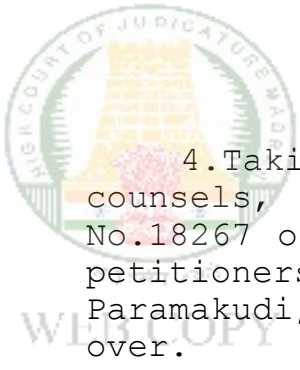

This petition has been filed to Crl.O.P.(MD)No.1996 of 2018 on 07.02.2019 modify the condition imposed on the petitioners in Crl.O.P.(MD)No.18267 of 2018 on 11.10.2018.
