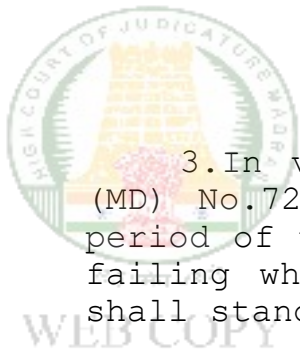

This petition has been filed to extend the time limit of the petitioner to execute the sureties and surrender before the concerned Magistrate Court.

2.The learned counsel for the petitioner seeks time to produce sureties. Since there was a difficulty in arranging the sureties, the petitioner is unable to execute the sureties within the stipulated time as per the order of Crl.O.P(MD) No.721 of 2019, dated 08.03.2019.



3. In view of the same, time granted by this Court in Crl.O.P (MD) No.721 of 2019, dated 08.03.2019, is extended further for a period of two weeks from the date of receipt of copy of this order, failing which the anticipatory bail already granted by this Court shall stand vacated automatically.
