3.In view of the same, time granted by this Court in Crl.M.P. (MD)No.3087 of 2019 in Crl.O.P(MD) No.22394 of 2018, dated 02.04.2019, is extended further for a period of two weeks from the date of receipt of copy of this order, failing which the



anticipatory bail already granted by this Court shall stand vacated automatically.
