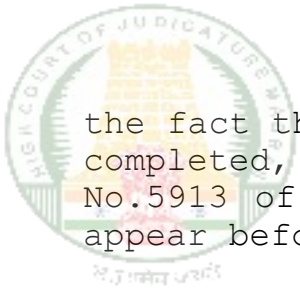

2.Heard Mr.T.A.Ebenezer, learned Counsel for the petitioners and Mr.A.Robinson, learned Government Advocate (Crl.Side) appearing for the State.

3.According to the learned counsel for the petitioners, the abovesaid condition is being complied with by the petitioners right from 29.04.2019 till date and therefore, the learned counsel seeks for relaxation. This fact has not been disputed by the learned Government Advocate (Crl.Side).
