Taking into consideration of the fact that the condition imposed by this Court is being complied with by the petitioners and the fact that substantial portion of the investigation has also been completed, the condition imposed by this Court in CrI.O.P.(MD) No.2926 of 2019 on 26.02.2019 is relaxed and the petitioners shall appear before the respondent police as and when required.
