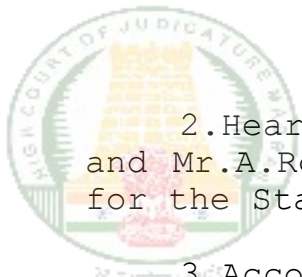

3. According to the learned counsel for the petitioners, the abovesaid condition is being complied with by the petitioners right from 03.05.2019 till date and therefore, the learned counsel seeks for relaxation. This fact has not been disputed by the learned Government Advocate (Crl.Side).

Taking into consideration of the fact that the condition imposed by this Court is being complied with by the petitioners and the fact that substantial portion of the investigation has also been completed, the condition imposed by this Court in Crl.O.P.(MD) No.5197 of 2019 on 12.04.2019 is relaxed and the petitioners shall appear before the respondent police as and when required.
