PRAYER :-

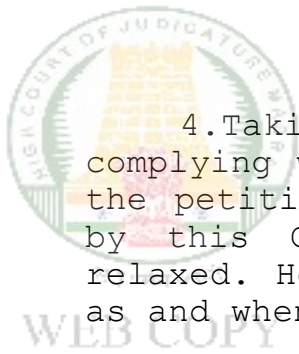
To relax the condition imposed by this Honourable Court by its order dated 21.02.2019 in Crl.OP(MD)No.2680 of 2019.
