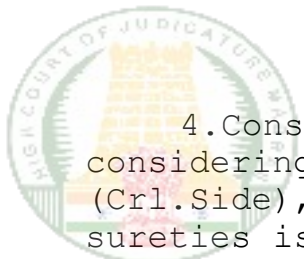

This Petition has been filed to extend the time granted by this Court in Crl.O.P.(MD)No.4468 of 2019, dated 26.03.2019, for producing the sureties and for executing the bail bond.

2.The learned counsel appearing for the petitioner would submit that the petitioner met with road accident and hence he could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court.
