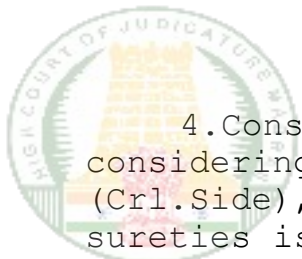

This Petition has been filed to extend the time granted by this Court in Crl.O.P.(MD)No.6142 of 2019, dated 26.04.2019, for producing the sureties and for executing the bail bond.

2.The learned counsel appearing for the petitioners would submit that since there was some difficulty in arranging sureties they could not surrender before the concerned Magistrate and execute the bail bond within a stipulated time as ordered by this Court. Hence, he prays to grant further time to execute the sureties.
