Taking into consideration the fact that the petitioner is complying with the condition regularly and there is no complaint of the petitioner tampering with the witnesses, the condition imposed by this court in Crl.O.P(MD)No.5901 of 2019 on 24.04.2019 is relaxed. However, the petitioner shall report before the respondent as and when required for interrogation.
